- Holding our 41st Annual Washington Conference, focused on hemispheric integration and including speeches by U.S. Secretary of State Hillary Clinton, President of El Salvador Mauricio Funes, and President of Mexico Felipe Calderón, along with other senior officials from across the Americas.
- Celebrating the fifth year of Americas Quarterly, which in 2011 focused on: Free Trade and Market Access;
 The New Brazil and the Changing Hemisphere; Sports: Business, Integration, and Social Change; and Impact Investing.
- Engaging members and constituents through our working groups on Hispanic integration and immigration, social inclusion, energy, and Cuba.
- Expanding and enhancing our cultural programs. Our critically acclaimed visual arts exhibitions included Antonio Manuel's first solo show in the United States. Our music program held a record number of performances and, for the first time, brought its programs to Miami. An important component of our Spring culture season focused on Cuba, with our partnership and participation in the ¡Sí Cuba! festival, as well as our literature series that featured prominent Cuban authors, playwrights, and poets.




