#### Dear Friends,

2008 was a dynamic year at Americas Society and Council of the Americas, as the organizations continued to innovate, grow, and increase our impact throughout the Americas. By providing a strategic space to build consensus and promote dialogue through private meetings, public programs, and policy analysis on vital topics in the Americas, we further strengthened the leadership role played by the two organizations.

Over the past year we held a record number of programs and leveraged our policy agenda to engage on new topics and with expanded audiences. Our 38th Annual Washington Conference on the Americas featured speeches by U.S. President George W. Bush and Panamanian President Martín Torrijos, as well as other top hemispheric figures. Over 300 business and policy leaders gathered to advance discussion on international trade, competitiveness, and regional relations.

Through our Presidents of the Americas series, we welcomed six presidents in total during the United Nations General Assembly week, holding public and/or private events for the presidents of Argentina, Brazil, Colombia, El Salvador, Panama, and Paraguay. Additionally, we were honored to present Brazilian President Luiz Inácio Lula da Silva with the Americas Society Gold Insigne in recognition of his exceptional achievements both in Brazil and around the world; in February, we were pleased to have the President of Mexico join our members at a private event.

As Co-Secretariat of the North American Competitiveness Council (NACC), Council of the Americas led efforts to promote increased engagement between the private and public sector. The NACC released its second report to the leaders of the United States, Canada, and Mexico in August 2008, with recommendations to improve regional competitiveness. Our Trade Advisory Group, meanwhile, spent 2008 crafting a major new report, *Building the Hemispheric Growth Agenda: A New Framework for Policy*, released January 2009.

With our 2008 Spring Party we gathered over 550 guests to honor three influential figures from the Americas: Patricia Phelps de Cisneros, Carlos Fuentes, and Peter Munk. At our 2008/2009 Inaugural Dinner, which launched the current season of programs at Americas Society, Dr. Glenn Hubbard of Columbia University Business School and Congressman Gregory W. Meeks spoke of the importance of engaging more closely with Latin America on common issues.

2008 was also a challenging year and we are truly appreciative of the support that each of you provided, which allowed the organizations to flourish in spite of a difficult operating environment. Special thanks also to those who generously gave of their time in support of the Board administrative and governance processes, in particular those who helped manage the endowment of the Americas Society to achieve better than anticipated results in an extremely difficult market. We look forward to continuing our partnership with all the individuals, corporations, foundations, and government agencies that have supported us, as we continue in our commitment to providing the premier forum for the hemisphere's opinion leaders to discuss the pressing issues of both today and tomorrow.

In 2008, our working groups sharpened their focus, issuing reports and convening experts for targeted analysis of issues ranging from trade to rule of law to energy. We launched an important new initiative, the Hispanic Integration Initiative, which engages with the U.S. and international business sectors to build dialogue on the importance and benefits of greater Hispanic integration.

Our cultural programming reached new heights of recognition and popularity, as audiences filled our landmark Park Avenue building to capacity to listen to concerts, book presentations, panel discussions, and view our visual arts exhibitions. Standouts include the exhibition *Carlos Cruz-Diez: (In)formed by Color*, a discussion with Pulitzer Prize-winning author Junot Díaz, and the second annual performance of rising opera singers from Argentina's renowned Instituto Superior de Arte del Teatro Colón.

The 2008 Spring Party was our most successful fundraiser ever, thanks in large part to our stellar group of honorees. Patricia Phelps de Cisneros, Peter Munk of Barrick Gold, and Mexican author Carlos Fuentes were honored for their outstanding achievements.

2008 presented some challenges but amazing opportunities. It was truly our best year ever. Many thanks to my team, whose hard work, dedication, and passion ensured that we reached both our strategic and financial goals. Additionally, I wish to extend a very special thank you to the Board of Directors of both organizations for your confidence, time, and unwavering commitment. Finally and most importantly, I want to thank all of you for your ongoing support and growing involvement in both organizations. Without you, none of this would be possible. 2009 will be a challenging year but with your continued engagement, our shared passion for our mission, and my team's commitment I am certain that we will achieve our goals.

### Overview

> Americas Society and Council of the Americas provide the premier forum for dialogue and analysis of hemispheric matters, bolstering engagement and strengthening relations among the countries of the region and between the public and private sectors. Our multifaceted agenda encompasses public policy programs, private off-the-record meetings, advocacy, publications, cultural offerings, educational initiatives, and other activities.

> In 2008 we held more than 180 programs in New York, Washington DC, Miami, and other cities throughout the hemisphere. We traveled to ten cities in Latin America, including Quito and Panama City for the first time, as well as traveling to two new cities in the United States, Atlanta and New Orleans. We brought together opinion leaders to offer their perspectives on today's most compelling subjects, highlighting current economic, political, and social trends with an eye toward future developments.

> Our website, AS/COA Online (www.as-coa.org), tripled its readership in 2008, providing a source for in-depth information on the Americas and an important tool for sustained interaction with our growing constituency. Our policy journal, *Americas Quarterly,* as well as our published reports, opinion pieces, and articles, continued to advance the policy agenda.

The new Hispanic Integration Initiative serves as one example of our broadening scope as we look toward emerging regional issues. Overall, our Working Groups intensified efforts to expand dialogue around issues crucial to progress and prosperity in the Western Hemisphere.

Our cultural programs packed the house, showcasing both established and emerging cultural figures from across the Americas. Visual arts exhibitions, concerts, book presentations, panel discussions, and our literary magazine *Review* explored the diversity of the Americas' cultural landscape.

During 2009 we plan to increase our impact, expanding our signature programming as well as launching many new initiatives as a means to reach new audiences and broaden and advance critical discussion and debate within the hemisphere. In this very challenging and dynamic environment our members remain our most valuable asset, as we work together to create a shared agenda for the coming year and beyond.

# Signature Programs in the U.S. Highlighting the Americas

2008 Americas Society and Council of the Americas signature programs continued to focus on topics of the utmost relevance to our members and the general public. Our signature programs offer high-level analysis of the region's most complex and vital issues, bringing together experts from the public and private sectors and academia to deepen understanding of current business, economic, social, and political trends.

Our **Latin America series** analyzes key and emerging issues facing Latin America as a whole. Programs included a panel discussion on the impact of the global financial crisis on Latin America, presentations by the U.S. Assistant Secretary of State for Western Hemisphere Affairs Thomas A. Shannon and Ecuador's Minister of the Interior Fernando Bustamante, and roundtables on the Andean region and strategic infrastructure in the Americas.

This year we focused extensively on the Pan-Pacific relationship, hosting a series of panel discussions in New York and Washington DC which examined the evolving ties between **Asia and Latin America.** In the lead-up to Peru hosting the 20th Annual APEC meeting, we brought APEC officials to New York and Washington DC for public and private events.

We held our **5th Annual Latin America Predictors Forum** in Miami, entitled "Assessing the Impact of the Global Financial Crisis in 2009." The U.S. Alternate Executive Director of the World Bank Ana M. Guevara and panelists offered predictions on macroeconomic policy and how the current environment translates into risk and select opportunities for the private sector.

### Latin American Cities series

Through our signature Latin American Cities series, Americas Society and Council of the Americas held major conferences and private events in nine cities in 2008, with an additional panel discussion in a tenth city. Expanding our geographic presence, AS/COA held conferences in Ecuador and Panama for the first time in 2008. With conferences in Argentina, Brazil, Chile, Colombia, Ecuador, Mexico, Panama, and Uruguay, we continue to position ourselves as the preeminent forum for the discussion of pressing regional issues. Our speakers and guests included presidents, ministers, high-ranking government officials, business leaders, policy makers, and academics who gathered to discuss economic and political trends, opportunities for growth and investment, trade and regional integration, energy, and other issues relevant to the region and each specific country.

In addition to conferences and private events, we held public panel discussions on such topics as corporate social responsibility, security, and immigration. In Bogota, our Rule of Law Working Group launched Estado de Derecho, Crecimiento Económico y Prosperidad, the Spanish-language translation of its report on achieving growth and prosperity through strengthening the rule of law. In Rio de Janeiro, panelists discussed public security policy at a private roundtable convened by the governor of Rio de Janeiro, Sergio Cabral. A panel in São Paulo addressed the evolution of corporate social responsibility in Brazil and throughout the hemisphere. Immigration trends and policies were the focus of a public panel and launch of the Americas Quarterly Summer issue in Buenos Aires.

In 2009 our Latin American Cities series will take us to new locations, including Paraguay for the first time.

### Presidents of the Americas Representing the Americas

As part of our **Presidents of the Americas** series, Americas Society and Council of the Americas hosted eight heads of state in the United States in 2008, including six during the week of the United Nations General Assembly in New York. At public and private events, the presidents of Argentina, Brazil, Colombia, El Salvador, Mexico, Panama, and Paraguay spoke to members, leading policy makers, government officials, and prominent guests about their country's current economic and political environment and opportunities for increased engagement and investment. Americas Society awarded Brazilian President Luiz Inácio Lula da Silva the Gold Insigne in recognition of his outstanding national and regional achievements. The Gold Insigne is Americas Society's highest honor, given to democratically elected heads of state who have made exceptional contributions to their countries and distinguished themselves globally.

Mexican President Felipe Calderón met privately with members in New York to discuss investment possibilities and the political climate in Mexico. In addition, the **38th Annual Washington Conference on the Americas** featured speeches by U.S. President George W. Bush and Panamanian President Martín Torrijos. Outside the United States, the heads of state of Mexico, Panama, and Peru spoke as part of our **Latin American Cities** series at their respective country's conference.

Barbara Span, Western Union In 2008 we launched an important new initiative, the **Hispanic Integration Initiative**, which examines the role of the private sector in Hispanic integration efforts. The white paper "U.S. Business and Hispanic Integration: Expanding the Economic Contributions of Immigrants" was published in July and released on Capitol Hill at a presentation featuring then-Senator Hillary Clinton and other congressional leaders.

Council of the Americas serves as the U.S. Co-Secretariat of the **North American Competitiveness Council (NACC)**, working closely with the private sector to promote cooperation with the U.S., Canadian, and Mexican governments and advance North American competitiveness. The **NACC** delivered its second *Report to Leaders* in April during the North American Leaders' Summit in New Orleans, in addition to meeting with security and prosperity ministers in Mexico and the United States.

The **Trade Advisory Group (TAG)**, which brings together leading trade experts to offer recommendations on trade and investment policy, held extensive meetings in advance of publishing a report on building the hemispheric growth agenda, released in January 2009. The **Energy Action Group (EAG)** spent much of 2008 preparing for a two-year initiative beginning in 2009. In addition, **EAG** organized the event "Global Energy Challenges: Implications for the Americas" in collaboration with Florida International University.

As part of ongoing efforts to expand its reach throughout the hemisphere, the **Rule of Law Working Group (ROLWG)** published the Spanish-language translation of its 2007 report *Rule of Law, Economic Growth, and Prosperity.* Created in 2006, **ROLWG** comprises a broad spectrum of experts dedicated to examining judicial and regulatory conditions in the Americas and identifying an agenda to improve the rule of law.

The **Brazil Study Group** continued to host leading figures from Brazil's business and political arenas at public and private events, providing informed discussion on Brazilian public policy and prospects for economic growth. Among numerous panel discussions, private meetings, and roundtables, highlights included a luncheon with five Brazilian governors, a dinner with representatives of Brazil's Growth Acceleration Program, and meetings with the president and CEO of Petrobras, the president of the Central Bank, and the ministers of Defense and Mines and Energy.









### Public Programs

In 2008 Americas Society and Council of the Americas hosted a wide range of public panels, deepening dialogue between politicians, leading policy makers, and regional experts. Forming a crucial part of our agenda, these panels cover the most relevant challenges and opportunities facing the hemisphere and aim to provide a better understanding of these issues for a wider audience. Stability in the face of the global financial crisis, energy security and diversification, strate gic infrastructure, microfinance, and the Andean region's current outlook were key topics explored during the year.

Some of the expert speakers included Colombian Vice President Francisco Santos Calderón, speaking on trade and the Colombian FTA, and Secretary General of the Organization of American States José Miguel Insulza, who examined the state of democracy in the region.


# Washington Conference on the Americas

The Council of the Americas' premier annual forum, the **38th Annual Washington Conference on the Americas**, featured speeches by U.S. President George W. Bush and Panamanian President Martín Torrijos. Entitled "The Globalization of the Americas," the conference convened business and policy leaders from across the hemisphere to hear views on competitiveness, international trade, finance, and U.S. relations toward the region. Presidents Bush and Torrijos were joined by other hemispheric leaders including U.S. Secretary of State Condoleezza Rice; Colombian Minister of Defense Juan Manuel Santos; Canadian Minister of Commerce Jim Prentice; Managing Director of the IMF Dominique Strauss-Kahn; U.S. Trade Representative Susan Schwab; Peruvian Minister of Finance Luis Carranza Ugarte; U.S. Secretary of Education Margaret Spellings; and U.S. Secretary of Commerce Carlos Gutierrez.

The Council of the Americas honored U.S. Congressman Gregory W. Meeks with its Chairman's Award for Leadership in the Americas at the conference's opening reception, hosted at the Inter-American Development Bank. Congressman Meeks, a member of the Subcommittee on the Western Hemisphere, was chosen for his leadership on issues impacting the Americas.

### Education and Advocacy

Through briefings, testimony, private meetings, and public panel discussions, the Council of the Americas represents our members' collective interests and increases understanding of topics including trade, investment, regulatory and judicial reform, and U.S. policy toward the region. We draw from an extensive network of relationships and in-depth knowledge of the issues defining the Americas agenda to meaningfully impact hemispheric dialogue. Trade expansion and enhanced linkages between North America, Latin America, and Asia are vital tools for promoting prosperity and connecting the region to the global economy, while encouraging necessary reforms and building competitiveness.

Throughout the year we provided congressional testimony on matters including trade, energy, Cuba policy, and a U.S.-Latin America primer for the new administration, in addition to publishing written materials. In 2008 we continued to lead efforts to promote the Colombia and Panama trade agreements, holding multiple events with the presidents and vice presidents and other top government officials to advance discussion. As the United States began negotiations to join the Trans-Pacific Strategic Economic Partnership, we hosted programs with the ambassadors of Australia, Chile, New Zealand, Peru, and Singapore to explore evolving trans-Pacific ties.

### Literature

Contemporary Canadian writing was the focus of the Spring 2008 series, which opened with a fiftieth anniversary celebration of the Canada Council featuring recipients of the 2007 Governor General's Awards. Other programs included a panel and reading with Quebecois novelists residing in the United States— Richard Hétu, Aimée Laberge, and Madeleine Monette; a public interview of the great Canadian playwright Michel Tremblay by Eleanor Wachtel of CBC Radio, part of the PEN World Voices festival; and a launch of issue 76 of *Review: Literature and Arts of the Americas*, featuring comments by the issue's editors Mark Abley and Sylvia Soderlind and readings by Canadian authors Ann Charney, Camilla Gibb, and Herménégilde Chiasson. Book presentations included launches of a new César Vallejo collection featuring author/scholar Ilan Stavans and translator Margaret Sayers Peden; a comprehensive anthology of Puerto Rican poetry edited by Roberto Márquez; and a celebration for Jorge Pinto Books, a multidisciplinary, multilingual publisher based in New York.

The Fall 2008 series examined immigration and writing in the Americas and beyond. It included a book presentation featuring Jamaican-U.S. writer Lorna Goodison; a public interview of the Pulitzer-Prize-winning Dominican-American author Junot Díaz by Cuban-American writer Achy Obejas; and "Immigrant Writing in the Americas, Europe, and Africa," a discussion with Chilean-U.S. author Marjorie Agosín, Trinidadian-Canadian author Neil Bissoondath, and Algerian-Italian author Amara Lakhous. The panel "In Search of the Audiencia" explored Spanish-language publishing in the United States. The season concluded with the launch of issue 77 of Review: Literature and Arts of the Americasan all-Mexican evening that brought together guest editors Carmen Boullosa and Lucía Melgar (UNAM), scholar Rubén Gallo, and authors Alvaro Enrigue and Naief Yehya. The season's offerings also included the panel "Machado and His Times," part of a citywide celebration of the great Brazilian writer Joachim Maria Machado de Assis. ### Music and Education

Throughout 2008 the Music Program strengthened its position as a leading presenter of music and musicians from Latin America, the Caribbean, and Canada. We produced a series of concerts, recordings, lectures, and educational activities featuring a wide variety of music from throughout the hemisphere. Collaborations with institutions such as the World Music Institute, Yale University's PIER Program, and Lincoln Center's Midsummer Night Swing enhanced our program offerings and increased our audience reach and diversity.

Americas Society's *Music of the Americas Concert Series* is renowned for its vibrant and diverse programming showcasing the range of styles and genres of classical, modern, and traditional music being produced in the Americas. Our 2008 concerts, offered to the public free of charge and held at our landmark concert venue in New York City, featured exciting highlights such as performances by Venezuelan violinist Eddy Marcano; Argentinean singer Maria Volonté; the TinAlley String Quartet, winner of the 9th Banff International String Quartet Competition; a return to Americas Society by rising opera singers from the Instituto Superior de Arte del Teatro Colón; and the New York premieres of works by Carlos Sánchez Gutiérrez and Roberto Sierra.

Our **Music Education** program is recognized for providing music instruction and interactive performances to underserved New York City public school children as well as for its **Music Education Partnerships** with arts education institutions looking to incorporate music from the Americas. In 2008 we collaborated with Yale University's PIER Program, providing performances and training on music from the Americas for public school teachers from throughout the eastern United States.

In Winter 2008 Americas Society presented **Torrijos: The Man and The Myth**, an exhibition of never-before-presented photographs of former Panamanian leader General Omar Torrijos by Graciela Iturbide, one of Mexico's most celebrated photographers. This exhibition explored the history of a complex era in Panama through the persona of Torrijos, the country's leader from 1968 to 1981 and one of Latin America's best-known twentieth century figures. A bilingual catalogue published by Umbrage Editions accompanied the exhibition, featuring the complete selection of photographs by Iturbide and previously unpublished personal reminiscences by Gabriel García Márquez, a confidant of General Torrijos.

The Spring 2008 exhibition, **Between Observation and Intervention: the Painted Photographs of Melvin Charney**, was the first solo show by the Canadian artist in a New York museum since his P.S. 1 installation in 1979. Montreal-based artist Melvin Charney's demanding and rhetorically complex body of work lies on the cutting edge between art and architecture. Among his most striking works are his large-scale painted photographs, in which stylized representations of buildings and building types are overlaid on mass media images. These works were the focus of the Americas Society show, which was organized in collaboration with the Musée National des Beaux-Arts du Quebec.

Americas Society's critically acclaimed Fall 2008 exhibition, **Carlos Cruz-Diez:** (In)formed by Color, was a landmark event. We presented the first U.S. solo exhibition featuring the Venezuelan, Paris-based kinetic art master's work, including an extraordinary site-specific environment of Cruz-Diez's *Cromosaturación* and a selection of his early *Fisicromías*. A pioneer in the use of color as an experience and a participatory tool, Cruz-Diez is a visionary who pushes the boundaries of art toward empowering the spectator.

Throughout 2008 the Visual Arts Program also hosted a series of oversubscribed public programs to accompany each exhibition, featuring outstanding artists, curators, critics, and scholars in the field. We hosted dialogues with artists including Cruz-Diez, Fernando Bryce, and Tercerunquinto; launched the Taschen publication *Diego Rivera. The Complete Murals;* presented a lecture on Brazilian Art Deco; and hosted a discussion on the Mapa de Cuauhtinchan No. 2.
