2024 Healthcare Dialogues



The Healthcare Dialogues continue to make meaningful contributions to shaping the future of healthcare in the Americas. The Healthcare Dialogues are an essential platform for fostering indepth conversations on the state of healthcare in Latin America and the Caribbean. In 2024, the series brought together a diverse array of experts, policymakers, and stakeholders, facilitating critical exchanges on health policy, challenges, and innovations across the region. Each dialogue explored vital issues such as healthcare access, system sustainability, and the impact of emerging health technologies, while also highlighting key opportunities for collaboration and progress. By addressing both immediate concerns and long-term solutions, the Healthcare Dialogues continue to make meaningful contributions to shaping the future of healthcare in the Americas.

The series remains focused on promoting public-private cooperation, increasing awareness of medical technologies and innovation, encouraging regulatory harmonization, and sharing best practices in health financing. It brings together COA members from a wide range of sectors, including pharmaceutical companies, food and beverage industries, medical device manufacturers, consumer health companies, technology firms, and shipping companies, fostering multi-sectoral dialogue and collaboration. These interactions bridge the gap between industries, promoting shared knowledge and collective solutions.

In 2024, we held Dialogues in Brazil, Colombia, Dominican Republic, Guatemala, and Mexico, expanding impact and offering members opportunities to engage directly with local stakeholders. In each country, the Dialogues included high-level discussions with key government officials and the heads of regulatory agencies, ensuring that the conversations remained grounded in actionable policy and regulatory frameworks. Through a combination of public panel discussions and private off-the-record meetings, the Healthcare Dialogues served as a platform for deepening understanding, identifying collaborative solutions, and setting the stage for future healthcare advancements in Latin America and the Caribbean.

2024 Snapshot of Activities

The Healthcare Dialogues had a dynamic and impactful 2024, beginning with a series of high-level meetings and continuing throughout the year with crucial conversations shaping the healthcare landscape in Latin America and the Caribbean.

JAN

MEXICO CITY

The year kicked off in Mexico City, where we hosted an exclusive members-only meeting with Oliva López Arellano, then-Secretary of Health of Mexico City. This gathering allowed members to hear directly from the Secretary about the city's advances in healthcare and her vision for ensuring the sustainable management of Mexico City's health system. This was followed by a high-level joint meeting, also members-only, with **Raquel** Buenrostro, then-Secretary of Economy and Alejandro Svarch, then-Federal Commissioner of Mexico's Federal Commission for Protection from Sanitary Risk (COFEPRIS). This was an outstanding opportunity for senior COA members to share their main concerns and priorities, discuss ways to strengthen and promote public-private collaboration, and learn more about regulatory advances and priorities. Additionally, participants were able to hear about the efforts jointly promoted by the Secretariat of Economy and COFEPRIS to encourage private investment and economic development in Mexico, particularly within the health ecosystem. These discussions highlighted opportunities to align regulatory frameworks with economic policies to attract investment and foster a more robust healthcare industry.

The session focused on strategies to strengthen collaboration between PAHO and the private sector, with a particular emphasis on public health, innovation, and access to healthcare services across the Americas.

Experts provided an overview on the value of self-care policies, while also analyzing opportunities and challenges for promoting self-care across the region. As countries in Latin America continue to address the challenge

of making their healthcare systems sustainable, the role of self-care has risen as an option to achieve significant savings and gains. The discussion focused on how integrating self-care into national health policies could not only alleviate pressure on overstretched healthcare systems but also contribute to improved health outcomes and long-term cost savings.

In August, we traveled to Bogotá to host a private members-only meeting with Francisco Rossi, Director of the National Institute for Food and Drug Surveillance (INVIMA). During this important meeting, we discussed topics such as strengthening the review committee, progress in the evaluation of

new registrations and technologies, and regulatory convergence mechanisms. The session provided a valuable opportunity to gain insights into the evolving regulatory landscape in Colombia and its impact on the healthcare sector.
